Growth roadmap	Advice	Develop a roadmap to increase your ability to trade in Australia and/or other markets.	A business in a specified growth sector who wants assistance to grow and enter new markets.	Broad review of your business, a roadmap and support from a mentor for up to one year.	Apply at any time.
High growth accelerator	Advice	Develop a growth plan to help you realise an Australian and/or overseas growth opportunity.	A business operating in a specified growth sector.	A customised growth plan and access to a facilitator who will assist with your growth opportunity for up to two years.	Apply at any time.
SMART projects and supply chains	Advice	Access to strategic or high-value projects that increase business capability, meet the specific needs of a market opportunity, or otherwise improve business performance and leadership capacity.	You must be a company participating in an identified project run by one of The Entrepreneurs' Programme growth facilitators.	Advice, guidance, and network connections.	Before you can apply you should have a SMART Projects and Supply Chains reference number.
Growth grant	Funding	Funding for businesses that have received one of the Growth services.	Businesses that have received a roadmap under one of the Growth services.	Funding of between \$2500 (ex GST) and \$20,000 (ex GST), covering up to 50% of eligible project costs.	You must submit your application within one year of receiving your roadmap or plan.

Businesses in one of the following growth sectors:  Advanced manufacturing  Food and agribusiness  Medical technologies and pharmaceuticals  Mining equipment, technology and services  Oil, gas and energy resources	Service Report that helps you understand your business's research needs and opportunities. A grant of up to \$50,000 that allows you to undertake a research project based on the report.	You can apply for an Innovation Connections Facilitation at any time. If you apply for an Innovation Connections Grant, you must apply within 12 months of receiving a Service Report.
