## **QUALIFICATIONS**

To qualify to serve on the Civil Grand Jury, you must meet the following requirements as outlined in Penal Code §893:

- Be a citizen of the United States; 18 years of age or older;
- A current resident of Monterey County and for one year immediately before being selected;
- Possess natural faculties of ordinary intelligence, of sound judgment, and of fair character;
- Possess sufficient knowledge of the English language.

## **DISQUALIFICATION**

A person is not legally qualified to apply or serve on the Civil Grand Jury if any of following apply:

- ♦ The person is serving as a trial juror in any California court;
- The person is serving as an elected public officer;
- The person has been discharged as a grand juror in any California court within one year;
- The person has been convicted of malfeasance in office or any felony or other high crime;
