




REMINDERS

The Monterey County Superior Court offers automated courtesy email and text (SMS) reminders for case hearings that are scheduled on the calendar. Reminders are sent 1 and 3 days before the hearing. To Sign-Up (Opt-in) for reminders for either a particular hearing or for all hearings on a case, please click on one of the links below and follow the steps below.

Sign up for Reminders from the Case View

1. Visit our portal @ <https://portal.monterey.courts.ca.gov/>
2. Using the Quick Search enter a valid Case Number and hit enter.



3. On the Case Information (details) page, navigate to the Hearings Tab to display future scheduled hearings. Click on the 'Future Hearing Reminder' to subscribe to all future hearings or Hearing Reminder to enable reminder on an individual hearing.






